

# PROJECT INTRODUCTION



## WHAT IS THIS EVENT?

**Cogeo Planning and Environmental Services Ltd. and Bluestone Energy Ltd. are proposing a Battery Energy Storage System (BESS) and associated infrastructure on land off Locks Street, Coatbridge, ML5 3RT.**

As the capacity of the development is over 20MW the development is classed as 'Major'. Ahead of submitting the Planning Application, the applicant is undertaking two in-person public consultation events to share the proposed development with the public and to gather feedback.

The development consists of 22 Battery Storage units with a generating capacity of 45MW. Existing access will be utilised, and a private access road has been proposed to service the BESS. In the lead-up to this event, leaflets about the project were circulated to nearby properties, and an advert appeared in the Airdrie and Coatbridge Advertiser.

### HALLYBURTON 100MW BESS

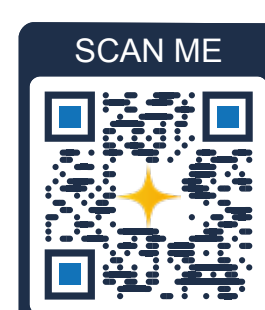
This application for a 100MW BESS site was submitted to the ECU in July 2024 and is currently going through the determination process.

### BRAIDFIELD 100MW BESS

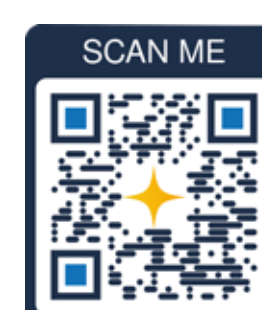
